TENTATIVE RESCISSION OF WASTE DISCHARGE REQUIREMENTS ORDER R5-2002-0140 FOR SKYVIEW TERRACE MOBILE HOME PARK, LLC, SKYVIEW TERRACE MOBILE HOME PARK, PLACER COUNTY

TO ALL CONCERNED PERSONS AND AGENCIES:

Enclosed is a tentative Rescission Order to rescind Waste Discharge Requirements Order R5-2002-0140 for Skyview Terrace Mobile Home Park in Placer County. The Central Valley Regional Water Quality Control Board (Central Valley Water Board) will consider adoption of the tentative Rescission Order at its 20/21 June 2024 meeting. Any written comments or evidence you may have concerning the tentative WDRs must be submitted to this office by **5:00 p.m. on 19 April 2024**. Absent a showing of good cause and lack of prejudice to other parties, the Central Valley Water Board Chair may exclude comments and evidence received after this deadline.

To conserve paper and reduce mailing costs, a paper copy of the tentative Rescission Order has been sent only to the Discharger.
