**NOTICE OF OPPORTUNITY TO COMMENT,
PUBLIC HEARING, AND FILING¹**

Concerning

AN AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE SACRAMENTO RIVER AND SAN JOAQUIN RIVER BASINS TO REMOVE THE MUNICIPAL AND DOMESTIC SUPPLY (MUN) BENEFICIAL USE IN TWELVE CONSTRUCTED AND/OR MODIFIED WATER BODIES IN THE SACRAMENTO RIVER BASIN THAT RECEIVE TREATED MUNICIPAL WASTEWATER FROM THE CITIES OF BIGGS, COLUSA, LIVE OAK OR WILLOWS

NOTICE IS HEREBY GIVEN THAT the Central Valley Regional Water Quality Control Board (Central Valley Water Board or Board) will accept comments regarding the development of an amendment (the "Proposed Amendment") to the Water Quality Control Plan for the Sacramento River and San Joaquin River Basins (Basin Plan). The Proposed Amendment would remove the Municipal and Domestic Supply (MUN) beneficial use in twelve constructed and/or modified water bodies in the Sacramento River Basin that receive treated municipal wastewater from the cities of Biggs, Colusa, Live Oak or Willows. The Proposed Amendment includes the following:

- Removal of the MUN beneficial use from twelve water bodies in the Sacramento River Basin that meet exception 2b in the State Water Resources Control Board's Sources of Drinking Water Policy (Resolution No. 88-63), which applies to water in systems designed or modified for the primary purpose of conveying or holding agricultural drainage waters.
- Monitoring and surveillance provisions consistent with Resolution No. 88-63, to assure that discharges from the systems comply with relevant water quality objectives.

The Board's Basin Planning Program is considered a certified regulatory program, which means that the Board is exempt from the requirement to prepare an environmental impact report for basin planning activities under the California Environmental Quality Act. (Pub. Res. Code, § 21080.5; Cal. Code Regs., tit. 14, § 15251(g).) The Board's environmental review of the proposed Basin Plan Amendments is instead contained in a draft Staff Report, which is considered to be "substitute environmental documentation" or "SED", and which will be posted on the Board's website (below) along with the Proposed Amendment no later than **5 January 2015**:

Written comments must be submitted to the above email or postal address by **20 February 2015** in order for them to be included in the administrative record.

At the February hearing, Board staff will provide the Board with initial recommendations regarding the Proposed Amendment and draft SED. The Board will provide members of the public and representatives of other agencies the opportunity to present oral comments on the Proposed Amendment and the adequacy of the SED. Though the Board may provide direction to Board staff, the Board will not take action on the Proposed Amendment at the February hearing.

Speakers are expected to orally summarize their written submittals. Oral testimony will be limited in time by the Board Chair. Groups are encouraged to designate a spokesperson. All exhibits presented at the hearings, including charts, graphs, and other testimony, must be left with the Board and will become part of the administrative record.
