ORDER NO. 88-16

**CHANGE OF OWNERSHIP/OPERATOR AND/OR NAME OF FACILITIES
HAVING WASTE DISCHARGE REQUIREMENTS**

The California Regional Water Quality Control Board, Colorado River Basin Region, finds that:


