### **OTHER BUSINESS**

17. Coachella Valley Salt and Nutrient Management Plan – Update – JR, CV IRWMP

Patti Reyes, CVWD Special Programs Manager and CVIRWMP Grant Administrator, described the goal of Salt and Nutrient Management Planning (SNP) is to facilitate basin wide management of all sources, including optimal uses of recycled water while ensuring protection of ground water and beneficial uses such as agricultural irrigation and human health.

18. Presentation by CVWD concerning areas within the district still on septic systems – Mark Johnson/Steve Bigley

Carrie Oliphant, CVWD Engineering Manager for Sanitation and Wastewater and Matt Palovido, CVWD GIS Manager, presented a map of areas within the CVWD boundaries which receive domestic water services but do not receive sanitation or wastewater services from the District.

19. Progress Report on Chromium Cleanup at PG&E Topock Compressor Station, South of Needles, CA, Adjacent to Colorado River – PG&E, EO

Sheryl Bilbrey, PG&E Director for Chromium Remediation, provided a brief history, including the location and purpose, of the PG&E Compressor Station. Ms. Bilbrey then described the Hexavalent Chromium (Cr+6) Groundwater Plume historically released from the Compressor Station cooling towers, the extensive Ground Water Monitoring System and the selected remedy for protecting the Colorado River from being impacted by the fugitive CR+6 plume. The selected remedy is in-situ conversion of the CR+6 to CR+3 utilizing the natural physical chemical properties of the subsurface soils along with chemical reduction facilitated by the injection of a substrate. The plume's migration will be accelerated through injection of groundwater from an external water source into several upgradient injection wells, and reinjection of downgradient treated groundwater in a pump-back system. Finally, Ms. Bilbrey discussed the importance of meeting Tribal expectations of causing minimal disruption to the natural environment. She also discussed the water quality issue of introducing the external source of groundwater from an Arizona well, which contains concentrations of naturally occurring Arsenic above Basin Plan water quality objectives.

Robert Perdue, Executive Officer, reported that the budget for the Water Boards appeared stable. Mr. Perdue stated he attended the Chairs' Meeting in Sacramento on April 11, 2014, with Vice Chair Nancy Wright.

22. Colorado River Basin Water Board Member Comments

Vice Chair Nancy Wright updated the members of the issues discussed at the April Chairs' Meeting, including the duties and responsibilities of Regional Board Chairs. Ms. Wright volunteered to participate on a Committee to further explore the roles and responsibilities of Board Members, including compensation and the total yearly cap on per diem for a single Regional Board.

23. Colorado River Basin Water Board Chair's Report — EW

The Chair thanked Ms. Wright for attending the Chairs' Meeting. The Chair also suggested to the other members that individual briefings with the Executive Officer and Legal Counsel in preparation for Board Meetings might be beneficial.
