ADMINISTRATIVE CIVIL LIABILITY COMPLAINT NO. R7-2006-0080  
ISSUED TO  
CITY OF WESTMORLAND  
FOR  
DISCHARGES OF EFFLUENT THAT EXCEED THE EFFLUENT LIMITATIONS  
OF THE TRIFOLIUM DRAIN NO. 6 IN VIOLATION OF BOARD ORDER NO. R7-2002-0004  
NPDES PERMIT NO. CA0105007

City of Westmorland (Discharger) owns and operates a sewage collection and disposal system and provides sewerage service to the City of Westmorland. On January 16, 2002, the California Regional Water Quality Control Board, Colorado River Basin Region (Regional Board) adopted Waste Discharge Requirements and a National Pollutant Discharge Elimination System (NPDES) Permit to regulate the discharge of treated municipal wastewater to the Trifolium Drain No. 6. The Permit is assigned NPDES Permit No. CA0105007, Board Order No R7-2002-0004.

The Assistant Executive Officer of the Regional Board has issued Administrative Civil Liability Complaint (ACLC) No. R7-2006-0080 against the Discharger, alleging that it discharged wastewater that exceeded effluent limits set forth in Board Order No R7-2002-0004. Pursuant to Section 13385 of the California Water Code, this complaint proposes that the discharger pay six thousand dollars (\$6,000) in mandatory minimum penalties for violations of specified effluent limitations. The Discharger may propose to spend an equivalent amount toward the implementation of a compliance project that is consistent with Section X of the Water Quality Enforcement Policy (Policy). The State Water Resources Control Board adopted the Policy on February 19, 2002 as Resolution No. 2002-0040, and it was approved by the Office of Administrative Law and became effective on July 30, 2002.

Unless the Discharger agrees to waive its right to a public hearing on the matter, as provided by California Water Code Section 13323(b), the Regional Board will proceed with the public hearing as follows:

Location: La Quinta City Council Chambers

During the hearing, the public and any other interested person can provide the Regional Board with comments on this matter.

If the Discharger waives its right to the hearing and pays the ACL in full, no hearing will be held. The settlement of this Complaint will become final 30 days from the date of this Public Notice. Persons wishing to file written comments on, or objections to, the proposed ACLC or any other aspects of this matter are required to do so within 30 days of the date of this Notice so that the Regional Board may consider the comments.
