**NOTICE OF APPLICATION AND PUBLIC HEARING FOR
NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT
AND WASTE DISCHARGE REQUIREMENTS**

The following discharger has filed an application for reissuance of a discharge permit under Section 402 of the Federal Clean Water Act National Pollutant Discharge Elimination System permit program (33 U.S.C. § 1342), Board Order R7-2010-0022:

In response to the application, staff of the California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board), has prepared tentative Board Order R7-2010-0022 (Tentative Order) for the above discharger. The Tentative Order contains effluent and receiving water limitations and special provisions in accordance with the federal Clean Water Act (33 U.S.C. § 1251 et seq.) and Division 7 of the California Water Code, commencing with Section 13000. The Tentative Order updates and replaces existing Board Order R7-2005-0021 and amending Board Order R7-2008-0027 (NPDES No. CA0104523). The Board will consider adoption of the Tentative Order in a public hearing that will be part of the public meeting scheduled for 10:00 a.m., May 20, 2010, City Council Chambers, City of La Quinta, 78-495 Calle Tampico, La Quinta, CA 92253.
