## NOTICE OF OPPORTUNITY TO COMMENT

PROPOSED APPROVAL OF AN AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE COLORADO RIVER BASIN REGION TO ESTABLISH A CONDITIONAL PROHIBITION FOR AGRICULTURAL WASTEWATER DISCHARGES ORIGINATING WITHIN THE PALO VERDE VALLEY AND THE PALO VERDE MESA, AND TO INCORPORATE AN IMPLEMENTATION PLAN

**NOTICE IS HEREBY GIVEN THAT** the State Water Resources Control Board (State Water Board) will accept comments on the Colorado River Basin Regional Water Board's (Colorado River Basin Water Board's) amendment to the Water Quality Control Plan for the Colorado River Basin Region that would establish a Conditional Prohibition for Agricultural Wastewater Discharges Originating within the Palo Verde Valley and the Palo Verde Mesa, and to Incorporate an Implementation Plan (Basin Plan amendment). The Basin Plan amendment was adopted by the Colorado River Basin Water Board on January 20, 2011, and is available for review as follows:

Requirements for Submitting Comments (Cal. Code Regs., tit. 23, § 3779): The State Water Board may refuse to accept any comments that do not satisfy the following requirements:

- a. Comments must specifically address the version of the Basin Plan amendment that was adopted by the Colorado River Basin Water Board.
- b. If the Colorado River Basin Water Board previously responded to a similar or identical comment, the commenter must explain why and in what manner the commenter believes each of the responses provided by the Colorado River Basin Water Board to each comment was inadequate or incorrect. If the comment does not include such an explanation, the State Water Board will presume that the Colorado River Basin Water Board's response adequately addressed the commenter's concern.
