Surface Water Augmentation Regs

- Update on status to our Board in December

SWRCB Peer Review Process (for SWA)

- Health and Safety Code Section 57004, requires all Cal/EPA organizations to submit for external scientific review:
 - The scientific basis and scientific portion of all proposed policies, plans and regulations.
 - Peer reviewers determine whether the scientific findings, conclusions, and assumptions are based upon sound scientific knowledge, methods, and practices

Expert Panel Briefing Papers

 - Outline a particular issue (topic)
 - Discuss issue background
 - Propose practical engineering/monitoring solutions and/or research
 - Provide findings and recommendations
- Briefing papers will be finalized at panel meetings Dec 2015 – Jun 2016

Review Advisory Group Role

- Advise the Expert Panel on feasibility
- Make recommendations to DDW on any other relevant topics such as:
 - Practical considerations for regulations that are protective of public health <u>and</u> achievable by project proponents
