 - ELTAC reached a recommendation on Field of Testing (FOT) lists, including recommending that ELAP certify laboratories on a per-analyte basis from the list of published methods, and that any additions to the certification lists should come from regulatory agency requests.
 - ELTAC recommended that ELAP's technical standard for laboratories consist of the method requirements of all approved methods. ELAP has accepted this recommendation.
 - ELTAC voted to support the development of a quality management system as a condition of accreditation for California.
