Dear Mr. Cordano:

On March 2, 2015, the State Water Resources Control Board, Division of Drinking Water (Division), issued Citation No. 01-10-15C-002 to the Department of Corrections and Rehabilitation (for the Deuel Vocational Institution Public Water System) for violating the Secondary Drinking Water Standards for Total Dissolved Solids, Specific Conductance, Chloride, and Manganese. Transmitted herewith is an amendment to the Citation. The Department of Corrections and Rehabilitation has requested an extension of Citation Directive No. 7, which requires Part 2 of the Corrective Action Plan to be submitted to the Division by September 30, 2015. Amendment No. 1 grants the request and extends the Directive No. 7 deadline to November 30, 2015.


Except as amended herein, all other terms of Citation No. 01-10-15C-002 shall remain in full force and effect.
