CITATION FOR VIOLATION OF CALIFORNIA HEALTH AND SAFETY CODE,
SECTIONS 116470
CONSUMER CONFIDENCE REPORT FOR 2014 CALENDAR YEAR
CITATION NO. 04_06_15C_022_5602110

Section 116650 of Chapter 4, Part 12, Division 104 of the California Health and Safety Code (CHSC), authorizes the issuance of a citation for failure to comply with a requirement of the California Safe Water Drinking Act, or any regulation, standard, permit, or order issued thereunder.

Violation

The Division of Drinking Water (hereinafter Division) of the State Water Resource Control Board issues a citation for violation of CHSC Section 116470 to Navalair Mobile Home Park. Specifically, the water system failed to submit a Consumer Confidence Report (CCR) and Certification form for the 2014 calendar year.

1 **Applicable Authorities**

2 **Section 116470 of California Health and Safety Code provides:**

3 (a) As a condition of its operating permit, every public water system shall annually
4 prepare a consumer confidence report and mail or deliver a copy of that report to
5 each customer, other than an occupant, as defined in Section 799.28 of the Civil
6 Code, of a recreational vehicle park. A public water system in a recreational
7 vehicle park with occupants as defined in Section 799.28 of the Civil Code shall
8 prominently display on a bulletin board at the entrance to or in the office of the
9 park, and make available upon request, a copy of the report.

13 **Background**

14 The CCR includes information about the water system, levels of detected contaminants,
15 and educational information. The deadline for submitting the CCR to the Division and
16 customers of the water system was July 1st, 2015. The Certification Form details how and
17 when the CCR was distributed. The deadline for submitting a Certification Form was Oct
18 1st, 2015. Navalair Mobile Home Park received a Notice of Violation on August 12th, 2015
19 for failing to submit a CCR.

21 **Directives**

22 Navalair Mobile Home Park must distribute its CCR and submit a copy to DDW by
23 **December 15, 2015**. A CCR certification form must also be submitted to DDW by
24 **December 15, 2015**. The CCR and Certification form should be submitted to:



Civil Penalties

Failure to comply with any provision of this citation will result in the Division imposing an administrative penalty not to exceed \$1000 (one thousand dollars) per day as of the date of violation of any provision of this citation.
