Citation for Noncompliance Total Coliform Monitoring and Reporting Violation

In accordance with Chapter 4, Article 9, Section 116650 of Part 1 of Division 104 of the California Health and Safety Code (CHSC), this Division is authorized to issue a citation for failure to comply with a requirement of Chapter 4 (California Safe Drinking Water Act), or any regulation, standard, permit or order issued thereunder.

Violation

The Yolo County Environmental Health Division (Division) hereby issues a citation to the Zamora Mini Mart Water System for failure to comply with Section 116555(a) of the CHSC and Section 64423 of Title 22, California Code of Regulations (CCR). Specifically Zamora Mini Mart Water System failed to collect and/or report the required number of bacteriological water samples for the second quarter 2016 as required by Section 64423(a) Title 22 of the CCR.

In accordance with Section 64423(a), Zamora Mini Mart is required to collect and have analyzed for total coliform bacteria, one sample from its distribution system per calendar quarter. As of this date, the Division has not received any results for a sample taken during the compliance period(s): Quarter II 2016. This is classified as a continuing violation.

Directives

Zamora Mini Mart is hereby directed to take the following actions:

1. Comply with Section 64423 in all future monitoring periods.
2. Notify all persons served by the Zamora Mini Mart water system of this violation by completing, posting, and returning a copy of Attachment A by **Friday, July 29, 2016**. This notice must include a written or typed description of corrective actions taken by the water system to prevent this violation from occurring in the future. This notice **must**

remain posted for a minimum of seven days following the return to compliance for monitoring and reporting.

3. Complete delinquent monitoring and provide the Division with results by **Friday, August 5, 2016.**

Civil Penalty

Sections 116650(d) and 116650(e) of CHSC allow for assessment of a civil penalty for failure to comply with requirements of Chapter 4. Failure to comply with any provision of this citation may result in the Division imposing a civil penalty of up to one thousand dollars (\$1,000.00) per day as of the date of violation of the provision.

**TOTAL COLIFORM MONITORING REQUIREMENTS NOT MET FOR
ZAMORA MINI MART**

The Zamora Mini Mart water system failed to monitor as required for drinking water standards during the past year and, therefore, was in violation of the regulations. Even though this failure was not an emergency, as our customers, you have a right to know what you should do, what happened, and what we did to correct this situation.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During Quarter II 2016, we did not monitor or test for total coliform bacteria and therefore, cannot be sure of the quality of our drinking water during that time.

What should I do?

- There is nothing you need to do at this time.
- The table below lists the contaminant(s) we did not properly test for during the last year, how many samples we are required to take and how often, how many samples we took, when samples should have been taken, and the date on which follow-up samples were (or will be) taken.
