**UPDATE: QUARTER 2, 2011 REPORTING DEADLINES AND QUARTERLY DAVIS-BACON CERTIFICATION**

The submittal deadlines for the Quarter 2, 2011 reporting period are quickly approaching. Please submit your American Recovery and Reinvestment Act (ARRA) project's quarterly report no later than **June 10, 2011** to CDPH. Also, please submit your supplemental report to CDPH no later than **July 5, 2011**. All reports must be submitted to [DWPFFunds@cdph.ca.gov](mailto:DWPFFunds@cdph.ca.gov). Please insure that the data included in your quarterly and supplemental reports accurately captures all information to be reported for the quarter. The ARRA quarterly reporting guidance and reporting forms can also be found at the following website:

As a reminder, all ARRA recipients are required to report quarterly until their ARRA project's last financial claim and Final Release Form have been submitted to CDPH. To terminate your reporting obligations, please submit your final quarterly report and a copy of the completed Final Release Form that was submitted with your final claim. Upon receipt of your final quarterly report as well as the Final Release Form, CDPH-DDWEM will acknowledge the fulfillment of your ARRA project's quarterly reporting obligations.

Please be advised that the United States Environmental Protection Agency is now requiring every ARRA funding recipient's Authorized Representative to certify on a quarterly basis to their project's compliance with the Davis-Bacon requirements, as prescribed in 29 CFR 5.5 (a)(1). As such, please ensure that your water system's Authorized Representative completes and signs the attached Davis-Bacon quarterly certification for the quarterly period from April 1, 2011 through June 30, 2011 and mails (postmarks) the certification to the following address by July 5, 2011:

Also, if quarterly Davis-Bacon certifications have not be signed and completed by your water system's authorized representative for all prior quarters since your project's funding agreement was executed, then please direct your authorized representative to complete and mail a separate certification for all prior quarters as soon as possible.
