We thank you for your previous attendance at one or more of our public workshops and/or your participation in our online survey regarding Climate Change Adaptation. Some of you have also indicated a willingness to stay engaged as we further develop a proposed Climate Change Adaptation Strategy. We have learned what matters to you, and we will continue to consider your input as we further develop the proposed actions.
