Dear Ms. Scoralle:

On behalf of the Save Our Forest Association (SOFA), the San Bernardino Mountains Group of the Sierra Club (Sierra Club), and Citizens of Crest Park (together, “SOFA et al.”), we write in support of the proposed Cleanup and Abatement Order requiring Arimol Group, Inc. and Meadowbrook Cedar, Inc. to restore surface waters damaged by unpermitted fill activities during the expansion of the Serenity Lodge alcohol and drug treatment facility in the Crest Park community of Lake Arrowhead. SOFA is a California non-profit corporation that since 1987 has fought on behalf of thousands of mountain residents to preserve the unique mountain quality of life and sought to prevent the type of watershed damage that occurred during the Serenity Lodge expansion. Since 1892, the Sierra Club has advocated to protect America’s wild creatures and places, including those in the San Bernardino Mountains. The Citizens of Crest Park organized to protect the quality of life in Crest Park and the surrounding mountain communities that are affected by the Serenity Lodge facility.

SOFA et al. have monitored the expansion of the Serenity Lodge facility and its unpermitted damage to surface waters, water quality, and wildlife habitat. Throughout the Serenity Lodge expansion, SOFA et al. advocated for treatment of the multi-parcel expansion as a single project for purposes of local permitting and environmental review, without success. Accordingly, SOFA et al. were heartened by the Regional Board’s approval of Administrative Civil Liability Order No. R6V-2013-0007 in January of this year, which assessed civil penalties for the facility’s violations of the Water Code and the

Clean Water Act on three parcels of land. The Order specifically found, "All of the disturbance was done by a common owner on contiguous properties as part of the expansion of the Serenity Lodge development." SOFA, the Sierra Club, and Citizens of Crest Park appreciate the Regional Board's holistic and accurate treatment of the Serenity Lodge expansion project, as well as its continuing efforts to restore the onsite watercourses through the proposed Cleanup and Abatement Order.

At this time, SOFA et al. wish to notify the Board of recent changes to the Serenity Lodge's ownership and management that may impact the enforceability of the Cleanup and Abatement Order. In November 2012, Serenity Lodge, Inc. was acquired by Rock Ridge Resources, Inc. in November 2012. (Attachment A, Press Release from Rock Ridge Resources.) KC Hollmer, President of Serenity Lodge, Inc., has been appointed President and Chairman of Rock Ridge Resources. (*Ibid.*) Additionally, as of April 4, 2013, Rock Ridge Resources, Inc. is named as the Department of Alcohol and Drug Programs licensee for the Serenity Lodge facility. For these reasons, SOFA et al would also support revising the proposed Order to add Rock Ridge Resources, Inc. as a named discharger, along with Arimol Group, Inc. and Meadowbrook Cedar, Inc.

Thank you again for the opportunity to comment on this important Cleanup and Abatement Order. SOFA, the Sierra Club, and Citizens for Crest Park support the Regional Board's efforts to bring the Serenity Lodge facility into compliance. We request notice of any future proceedings regarding this matter.
