TO THE WATER QUALITY CONTROL PLAN FOR THE LOS ANGELES REGION TO INCORPORATE A TMDL FOR NITROGEN COMPOUNDS AND RELATED EFFECTS IN CALLEGUAS CREEK, ITS TRIBUTARIES AND MUGU LAGOON – AND THE REVISED STAFF

REPORT

On October 24, 2002, the California Regional Water Quality Control Board, Los Angeles Region (Regional Board) adopted Resolution 02-017 to incorporate a Total Maximum Daily Load (TMDL) to reduce nitrogen compounds loading to Calleguas Creek, its tributaries and Mugu Lagoon into the Water Quality Control Plan, Los Angeles Region (Basin Plan).

The Regional Board adopted Resolution 02-017 pursuant to Division 7 of the California Water Code at a public hearing held on October 24, 2002. The Regional Board considered the tentative amendment which was transmitted to interested parties and posted on its website on August 30, 2002, as well as the Regional Board Staff Report, also posted on the Regional Board website, written comments from interested parties, Regional Board staff response to written comments and resultant change sheet, and oral testimony from Regional Board staff and interested parties. The Regional Board considered all submittals, testimony, and factors associated with this matter and adopted the Basin Plan Amendment, Resolution 02-017.
