SUBJECT: MINOR, NON-SUBSTANTIVE CORRECTIONS TO THE BASIN PLAN AMENDMENT ADOPTED IN REGIONAL BOARD RESOLUTION NUMBER 2003-012, MARINA DEL REY HARBOR MOTHERS' BEACH AND BACK BASINS BACTERIA TMDL

At a Regional Board hearing on August 7, 2003, our Board adopted Resolution No. 2003-12 to incorporate the Marina del Rey Harbor Mothers' Beach and Back Basins Bacteria TMDL into the Basin Plan. The Resolution authorizes me, as the Regional Board Executive Officer, to make minor, non-substantive corrections to the language of the Basin Plan amendment if the Office of Administrative Law (OAL) or State Water Resources Control Board (SWRCB) determines during the approval process that the corrections are needed for clarity or consistency. The SWRCB has determined that minor, non-substantive corrections are necessary for clarity and consistency in this Basin Plan Amendment. Therefore, I hereby make the changes as indicated in Attachment A hereto, which are minor and nonsubstantive corrections to the language of the Amendment. Also attached are the revised Basin Plan amendment strike-out version and the final revised Basin Plan amendment with non-substantive corrections (pages 9-5 through 9-16 of the Administrative Record).
