On Thursday, August 25, 2016, you were sent electronic versions of the following items related to Paradise Cove in preparation for the September 8th Board meeting:

- 1. Response to Comments;
- 2. Revised tentative WDRs/WRRs Order No. R4-2016-XXXX;
- 3. Revised tentative Monitoring and Reporting Program No.8342; and,
- 4. Revised tentative Cease and Desist Order No.R4-2016-XXX

We hereby submit a 2nd revised tentative WDRs/WRRs (Order No. R4-2016-XXXX) dated August 26, 2016 (attached) to replace the one dated August 25, 2016 that you received yesterday. Two changes have been made to this order. They are notated in track changes.

The first change is a clarifying change that revises the title to Table 6. **Groundwater Limitations for Paradise Cove**Mobile Home Park and Paradise Cove Wastewater Treatment Plant (combined system) and that adds a new Table 7.

Groundwater Limitations for Paradise Cove Beach Café from September 8, 2016 to August 31, 2018 only. These changes clarify what groundwater limitations apply to groundwater wells that are used for the currently used separate treatment and disposal systems vs. what groundwater limitations apply to the wells used for the planned combined system. This was described in Finding 54, but was not fully integrated into the section B. GROUNDWATER LIMITATIONS.

The second change is adding an effluent limit for *Enterococcus* to Table 5. This limit is applicable to Beach Café effluent from September 8, 2016 to August 31, 2018. There is currently a groundwater limit for *Enterococcus* but not an effluent limit. This effluent limit is proposed following the review of recently submitted effluent monitoring data that show a previous period of discharging at levels that met the Ocean Plan standards for *Enterococcus* followed by recent higher levels in the second quarter 2016. This illustrates that the disinfection system can operate properly to meet the limits, but that operational changes are needed to bring the system back into proper operation to be able to comply with Ocean Plan standards for *Enterococcus*.

Written comments will be accepted on these two changes only by 5pm, Thursday, September 1, 2016.
