TENTATIVE AMENDED CEASE AND DESIST ORDER FOR SATICOY SANITARY DISTRICT (JOSE FLORES WASTEWATER TREATMENT PLANT), 1419.5 LIRIO STREET, SATICOY, CALIFORNIA (FILE NO. 54-008, ORDER NOS. R4-2013-0092 and R4-2013-0098, CI-1761, GLOBAL ID WDR100000104)

Dear Mr. Acosta,

The California Regional Water Quality Control Board, Los Angeles Region (Regional Board), is the state agency with primary responsibility for the protection of ground and surface water quality for all beneficial uses within major portions of Los Angeles and Ventura Counties, including the referenced property above.

Regional Board staff have completed the review of a time extension request for Cease and Desist Order (CDO) No. R4-2013-0098 for the Jose Flores Wastewater Treatment Plant owned by the Saticoy Sanitary District. Pursuant to the California Water Code, a tentative amended CDO has been prepared. Enclosed is a copy of tentative amended CDO.

In accordance with administrative procedures, the Regional Board will consider the enclosed tentative amended CDO and comments thereon, at a public hearing to be held at 9:00 AM on June 11, 2015, at the Board Room, Metropolitan Water District of Southern California located at 700 North Alameda Street, Los Angeles, California. The Regional Board will hear any testimony pertinent to the tentative amended CDO. It is expected that the Regional Board will take action at the hearing; however, as testimony indicates, the Regional Board at its discretion may postpone action. See enclosed Notice of Opportunity for Public Comment and Public Meeting.

Written comments or testimony regarding the tentative amended CDO must be received at the Regional Board's Office by **5:00 PM on May 22, 2015**. Comments received after this date will not be accepted into the record unless determined by the Chair of the Regional Board not to prejudice any party or the Regional Board.

The agenda for the meeting will be posted on the Regional Board's website (http://www.waterboards.ca.gov/losangeles/board_info/agenda/index.shtml) approximately one week prior to the meeting.
