TENTATIVE AMENDED TIME SCHEDULE ORDER (TSO) NO. R4-2015-0174-AX REQUIRING AES ALAMITOS LLC, ALAMITOS GENERATING STATION TO COMPLY WITH REQUIREMENTS PRESCRIBED IN ORDER NO. R4-2015-0173 – AES ALAMITOS, LLC, ALAMITOS GENERATING STATION, LONG BEACH, CALIFORNIA (NPDES NO. CA 0001139, CI NO. 6113)

Dear Mr. O'Kane:

The California Regional Water Quality Control Board, Los Angeles Region (Regional Water Board) has reviewed the "Request for Extension of Deadlines Associated with TSO R4-2015-0174-A01" submitted by AES Alamitos LLC (Discharger) on March 12, 2018. The request stated that due to the City of Long Beach sewer line permitting process and the California Public Utilities Commission (CPUC) Resource Adequacy contract certain compliance dates need to be changed.

The enclosed tentative TSO amendment No. R4-2015-0174-AX includes the new schedule required to achieve compliance with the final effluent limitations contained in Order No. R4-2015-0173. All other provisions remain the same as in TSO No. R4-2015-0174-A01.

Also enclosed is the Notice of Proposed Issuance of TSO No. R4-2015-0174-AX. As indicated in the Notice, the Executive Officer, pursuant to delegated authority from the Regional Water Board, will consider whether to issue the TSO amendment without a public hearing. Written comments must be submitted by **5:00 p.m. on June 18, 2018,** and in accordance with the procedures provided in the Notice. The Regional Water Board will neither consider nor respond to untimely written comments.
