POSTPONEMENT OF BOARD CONSIDERATION FOR ADOPTION OF THE TENTATIVE TERMINATION OF WASTE DISCHARGE WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT FOR CALIFORNIA SULPHUR COMPANY, WILMINGTON, CA. (NPDES NO. CA0059064, CI NO. 6546)

Our letter dated March 5, 2015, informed you that consideration of the tentative termination of Waste Discharge Requirements (WDRs) for the subject facility would be heard during May 14, 2015, Board Hearing. During the April 8, 2015, teleconference call between California Sulphur Company and Regional Water Board staff, you requested to postpone the Board hearing for consideration of this item to evaluate options for managing wastewater stored onsite for reuse and the storm water only discharge.

Consideration of the tentative WDRs has been postponed to a future Board Hearing. We will advise you accordingly of the new Board Hearing date and location.
