The following changes to the revised tentative amendment are clarifications suggested by Regional Water Board staff.

1. Waste Discharge Requirements Section II.A, Agenda Page 5-054, (WDR Page 3). Clarify the connections to the RSMP.
 - A. Purpose of Amendment to Order R4-2-014-0033.** Therefore, this Order amends Order R4-2014-0033 to allow the recycled water to be discharged into RSMP and transported via RSMP to the PVCWD's irrigation distribution system and to the irrigation systems of two individual growers on the Oxnard Plain. Separate WDRs will authorize additional discharge points in order to connect the RSMP to the PVCWD's irrigation distribution system and to the irrigation systems of two individual growers on the Oxnard Plain.
2. Fact Sheet Section I.E.2, Agenda Page 5-015, (Fact Sheet Page F-4). Clarify the connections to the RSMP.
 - 2.** Allow use of the RSMP to convey a blend of desalinated recycled water from the AWPF and brine discharge from Camrosa's Round Mountain Water Treatment Plant ~~through the PVCWD distribution system to agricultural users within~~ to the PVCWD irrigation distribution system and to the irrigation systems of two individual growers on the Oxnard Plain for irrigation of crops.
3. Fact Sheet Section I.F., Agenda Page 5-015, (Fact Sheet Page F-4). Clarify the connections to the RSMP.
 - F.** Therefore, this Order amends Order R4-2014-0033 to allow the recycled water to be discharged into RSMP and transported via RSMP. Separate WDRs will authorize additional discharge points in order to connect the RSMP to ~~agricultural users within~~

~~the Oxnard Plain through the PVCWD's irrigation distribution system~~ the PVCWD irrigation distribution system and to the irrigation systems of two individual growers on the Oxnard Plain for irrigation of crops.

4. Fact Sheet Section II.A., Agenda Pages 5-018 & 5-019, (Fact Sheet Pages F-7 & F-8). Clarify the connections to the RSMP.

A. Description of Wastewater and Biosolids Treatment and Controls

Temporary Discharge of AWPf Recycled Water

CMWD, on May 11, 2015, requested that the NPDES Permit No. CA0064521 (Order R4-2014-0033) be modified to allow the discharge of recycled water from the Advanced Water Purification Facility (AWPF) to the RSMP and the subsequent discharge of the recycled water mixed with discharges from Camrosa's Round Mountain Water Treatment Plant to the PVCWD's irrigation distribution system. The discharge to the PVCWD's irrigation distribution and to the irrigation systems of two individual growers on the Oxnard Plain is regulated by Order R4-2011-079-A01. AWPf water discharged to the RSMP that is not delivered to ~~the PVCWD~~ or to individual growers on the Oxnard Plain for irrigation will be discharged at the RSMP outfall and must comply with the effluent limits contained in this Order.
