## **NOTICE OF PUBLIC HEARING**

## PROPOSED REISSUANCE OF

# WASTE DISCHARGE REQUIREMENTS (National Pollutant Discharge Elimination System Permit)

The City of Los Angeles (hereinafter Discharger or Permittee) and the City of Glendale entered into a joint venture in the 1960s to begin planning for the construction of Los Angeles Glendale WRP (LAGWRP). While the City of Glendale originally owned the land, it was eventually deeded over to the City of Los Angeles to facilitate the construction and operation of Los Angeles Glendale WRP. City of Glendale is recognized as joint and equal owner of the plant and its effluent as stated in the Joint Powers Agreement between the two cities. Being an equal owner in the plant entitles the City of Glendale to independently apply for water rights to expand its reclaimed water system as well as submit engineering reports to State regulatory agencies.

The Discharger and the City of Glendale jointly own the LAGWRP. However, the Discharger is granted sole authority to operate LAGWRP pursuant to the Joint Powers Agreement between the two cities. The LAGWRP, a tertiary wastewater treatment plant, is located at 4600 Colorado Boulevard, Los Angeles, California. LAGWRP currently receives wastewater from the cities of Glendale, Burbank, Los Angeles, and La Canada-Flintridge and from Los Angeles Zoo. The discharge of wastewater is regulated under Order No. R4-2011-0197 and National Pollutant Discharge Elimination System (NPDES) Permit No. CA0053953 adopted on December 8, 2011. This Order was subsequently revised by Order No. R4-2011-0197-A01 adopted on July 12, 2012.. Order No. R4-2011-0197 also serves as a permit under the National Pollutant Discharge Elimination System (NPDES No. CA0053953).

The LAGWRP is a tertiary wastewater treatment plant that treats municipal wastewater from domestic, commercial, and industrial sources. The treatment at the LAGWRP currently consists of barscreen removal of large solids, primary sedimentation, activated sludge biological treatment with nitrification and denitrification, secondary sedimentation with coagulation, dual-media and deep bed sand filtration, chlorination, and dechlorination. There are no facilities provided for solids processing at the treatment plant. Sewage solids separated from the wastewater are returned to the trunk sewer for conveyance to North Outfall Sewer, where treatment and disposal occur, under Hyperion Wastewater Treatment Plant's NPDES permit. The LAGWRP is designed to treat 20 million gallons per day (mgd). The LAGWRP discharges the treated wastewater to the Los Angeles River, a water of the United States, at a point located

approximately 1,400 feet downstream of Colorado Boulevard (Latitude 34.14028°, Longitude - 118.29000°), in the Los Angeles River, above the river Estuary.

On the basis of preliminary staff review and application of lawful standards and regulations, the California Regional Water Quality Control Board, Los Angeles Region, tentatively proposes to issue waste discharge requirements, including effluent limitations and special conditions.

The Regional Water Board will hold a public hearing on the tentative WDRs during its regular Board meeting on the following date and time and at the following location:

Interested persons are invited to attend. At the public hearing, the Regional Water Board will hear testimony, if any, pertinent to the discharge, WDRs, and permit. Oral testimony will be heard; however, for accuracy of the record, important testimony should be in writing.

Should any interested persons desire staff to bring to the hearing any particular documents that are not included in the agenda packet, they must submit a written or electronic request to staff during business hours, not later than five business days

before the hearing. The request must identify the documents with enough specificity for staff to locate them.

## PUBLIC COMMENTS AND SUBMITTAL OF EVIDENCE

Persons wishing to comment on, or object to, the tentative waste discharge requirements, or submit evidence for the Board to consider, are invited to submit them in writing to Raul Medina at the above address, or send them electronically to <a href="mailto:raul.medina@waterboards.ca.gov">raul.medina@waterboards.ca.gov</a>. To be evaluated and responded to by Regional Water Board staff, included in the Board's agenda folder, and fully considered by the Board, written comments or testimony regarding the tentative must be received no later than 5:00 p.m. on February 6, 2017. Failure to comply with these requirements is grounds for the Regional Water Board to refuse to admit the proposed written comment or exhibit into evidence pursuant to section 648.4, title 23 of the California Code of Regulations.

## NATURE OF HEARING

This proceeding will be a formal adjudicatory proceeding. For such proceedings, the Regional Water Board follows procedures established by the State Water Resources Control Board. These procedures are set forth in regulations commencing with section 647 of title 23 of the California Code of Regulations, in particular, Article 2, commencing with section 648.

## PARTIES TO THE HEARING

The following are the parties to this proceeding:

City of Los Angeles/permittee

Any other persons requesting party status must submit a written or electronic request to staff not later than 20 business days before the hearing. All parties will be notified if other persons are so designated.

#### **HEARING PROCEDURE**

The Board meeting, of which this hearing is a part, will start at 9:00 a.m. Interested persons are invited to attend. When the agenda item is called, staff will present the matter under consideration, after which oral statements from parties or interested persons will be heard. For accuracy of the record, all important testimony should be in writing. The Board will include in the administrative record written transcriptions of oral testimony that is actually presented at the hearing. Oral testimony may be limited to five minutes or less for each interested person, depending on the number of interested persons wishing to be heard.

Parties or interested persons with similar concerns or opinions are encouraged to choose one representative to speak and are encouraged to coordinate their presentations with each other. Parties will be advised after the receipt of public comments, but prior to the date of the hearing, of the amount of time each is allocated for presentations. That decision will be based upon the complexity and number of issues under consideration, the extent to which the parties have coordinated, the number of parties and interested persons anticipated, and the time available for the hearing. The parties are invited to contact staff not later than **February 16, 2017** (two weeks prior to the hearing) to discuss how much time they believe is necessary for their

presentations, and staff will endeavor to accommodate reasonable requests. At the conclusion of testimony, the Board will deliberate in open or close session, and render a decision.

The Board does not generally require the prior identification of witnesses, the cross examination of witnesses, or other procedures not specified in this notice. Parties or persons with special procedural requests or requests for alternative hearing procedures should contact staff, who will endeavor to accommodate reasonable requests. Objections to any procedure to be used during this hearing must be submitted in writing no later than close of business 15 business days prior to the date of the hearing. (Any objections related to the amount of time allocated for parties' presentations must be submitted within two business days of notice thereof, if that date is less than 15 business days before the hearing.) Absent such objections, any procedure not specified in this hearing notice will be waived pursuant to section 648(d) of title 23 of the California Code of Regulations. Procedural objections will not be entertained at the hearing.

If there should not be a quorum on the scheduled date of this meeting, all cases will be automatically continued to the next scheduled meeting in **April 6**, **2017**. A continuance will not extend any time set forth herein.
