REVISED TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT — CITY OF LOS ANGELES, DEPARTMENT OF WATER AND POWER, SCATTERGOOD GENERATING STATION, 12700 VISTA DEL MAR, PLAYA DEL REY, CALIFORNIA (NPDES PERMIT NO. CA0000370, CI-1886)

On October 22, 2015, we transmitted the Response to Comments and the revised tentative Waste Discharge Requirements (WDRs) and National Pollutant Discharge Elimination System (NPDES) Permit for the Scattergood Generating Station. The revised tentative permit incorporated changes addressed in the Response to Comments. On November 4, 2015, Regional Board staff received new information from the Discharger concerning changes to the routing of the in-plant waste stream. This new information will result in a number of substantial changes to the proposed revised tentative permit. Therefore, a revised tentative permit (dated 11/9/2015) has been prepared. Changes in the revised tentative permit appear in the strikeout/underline format.

The Board will hear any testimony pertinent to this discharge and the revised tentative requirements. It is expected that the Board will take action at the hearing; however, as testimony indicates, the Board, at its discretion, may order further investigation.

Written comments regarding this revised tentative Order must be received at the Regional Water Board office by 5:00 p.m. on December 11, 2015. Timely submittal of written comments is encouraged to ensure that all comments are accurately and fully included in the administrative record, that Board staff is able to provide timely review, and that Regional Board members have sufficient time to give full consideration to the comments and issues raised. The Regional Water Board chair may exclude from the record written materials received after this date (See Cal. Code Regs., tit. 23 § 648.4.).
