REVISED TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRs)/ NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT AND RESPONSE TO COMMENTS – SANTA CLARITA VALLEY SANITATION DISTRICT OF LOS ANGELES COUNTY (SCVSD), VALENCIA WATER RECLAMATION PLANT (NPDES NO. CA0054216, CI-4993)

We have revised the tentative WDRs and NPDES permit dated February 11, 2015, based on comments received by the March 13, 2015, public comment deadline. A copy of the revised tentative Order, written responses to all comments received, and a proposed change sheet are enclosed. Changes to the tentative WDRs appear in ~~strikeout~~ and underline format. Written comments are not being solicited regarding the revised tentative order.

In accordance with administrative procedures, the Los Angeles Regional Water Board at a public hearing to be held on **April 9, 2015, at 9:00 a.m., but is not due to be heard before 1 p.m.**, at the **Metropolitan Water District of Southern California Board Room, 700 North Alameda Street, Los Angeles, California**, will consider the enclosed Revised Tentative Requirements and comments submitted in writing regarding the Revised Tentative NPDES Order. The Board will hear any testimony pertinent to this discharge and the tentative requirements. It is expected that the Board will take action at the hearing; however, as testimony indicates, the Board, at its discretion, may order further action by staff. The agenda for the meeting will be posted on the Los Angeles Regional Water Quality Control Board's website (http://www.waterboards.ca.gov/losangeles/board_info/agenda/index.shtml) approximately one week prior to the meeting.
