Proof of posting shall consist of a statement executed on the enclosed form; proof of publication shall consist of an affidavit of the publisher or foreman of the newspaper, with a copy of the notice as published, attached. Proof of posting or publication must be submitted to this Board by October 11, 2017.

NOTICE OF PUBLIC HEARING

PROPOSED ISSUANCE OF WASTE DISCHARGE REQUIREMENTS (NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT)

DISCHARGER City of Thousand Oaks (Hill Canyon Wastewater Treatment Plant) DISCHARGE LOCATION 9600 Santa Rosa Road Camarillo, California <u>RECEIVING WATER</u> North Fork Arroyo Conejo (tributary to Calleguas Creek)

The City of Thousand Oaks owns and operates a publicly-owned treatment works (POTW) comprised of the Hill Canyon Wastewater Treatment Plant (Hill Canyon WWTP) and its associated wastewater collection system and outfalls. The Hill Canyon WWTP is located at 9600 Santa Rosa Road, Camarillo, California, with a design capacity of 14.0 million gallons per day (MGD).

The Facility discharges tertiary-treated wastewater, from its Hill Canyon WWTP to North Fork Arroyo Conejo, tributary to Calleguas Creek, waters of the United States. The Permittee is regulated under waste discharge requirements contained in Order No. R4-2014-0064-A01, which serves as a permit under the National Pollutant Discharge Elimination System (NPDES No. CA0056294) and under Time Schedule Order No. R4-2014-0065-A02. Regional Water Board staff prepared tentative Amendment Order No. R4-2014-0064-AXX for the Waste Discharge Requirements (WDRs) and NPDES for the Hill Canyon WWTP, in accordance with the permit reopener contained in section VI.C.1.i of the NPDES Order which states that the "Order may be reopened and modified, to add or revise effluent limitations as a result of future Basin Plan Amendments, such as an update of a water quality objective, or a revision of any of the Calleguas Creek TMDLs." Order R4-2014-0064-AXX proposes to update the copper final effluent limitation consistent with the updated Waste Load Allocation contained in the *Total Maximum Daily Load for Metals and Selenium in the Calleguas Creek, its Tributaries and Mugu Lagoon (Amended Metals TMDL)*, which was adopted by this Regional Water Board on October 13, 2016, and went into effect on June 23, 2017.

On the basis of preliminary staff review and application of lawful standards and regulations, the California Regional Water Quality Control Board (Regional Water Board), Los Angeles Region, tentatively proposes to issue amended waste discharge requirements, including revised final effluent limitations for copper.

PUBLIC HEARING DATE AND LOCATION

The Regional Water Board will hold a public hearing on the tentative WDRs during its regular Board meeting on the following date and time and at the following location:

Interested persons are invited to attend. At the public hearing, the Regional Water Board will hear testimony, if any, pertinent to the discharge, WDRs, and permit. Oral testimony will be heard; however, for accuracy of the record, important testimony should be in writing.

SCOPE OF HEARING

The validity of the Total Maximum Daily Loads (TMDLs) for Calleguas Creek Watershed are not at issue before the Regional Water Board in this proceeding. Evidence or argument that challenges the validity of those requirements, or any aspects of them will not be permitted. The only matter before the Board is the adoption of new WDRs and permit under the NPDES to incorporate applicable water quality objectives associated with discharges to the waters of the United States.

The request must identify the documents with enough specificity for staff to locate them.

PUBLIC COMMENTS AND SUBMITTAL OF EVIDENCE

Persons wishing to comment on, or object to, the tentative waste discharge requirements, or submit evidence for the Board to consider, are invited to submit them in writing to Veronica Cuevas above address. at the or send them electronically to veronica.cuevas@waterboards.ca.gov. To be evaluated and responded to by Regional Water Board staff, included in the Board's agenda folder, and fully considered by the Board, written comments or testimony regarding the tentative must be received no later than 5:00 p.m. on October 11, 2017. Failure to comply with these requirements is grounds for the Regional Water Board to refuse to admit the proposed written comment or exhibit into evidence pursuant to section 648.4, title 23 of the California Code of Regulations.

NATURE OF HEARING

This proceeding will be a formal adjudicatory proceeding. For such proceedings, the Regional Water Board follows procedures established by the State Water Resources Control Board. These procedures are set forth in regulations commencing with section 647 of title 23 of the California Code of Regulations, in particular, Article 2, commencing with section 648.

PARTIES TO THE HEARING

The following are the parties to this proceeding: City of Thousand Oaks

Any other persons requesting party status must submit a written or electronic request to staff not later than 30 business days before the hearing. All parties will be notified if other persons are so designated.

Regional Water Board staff is not a party to the proceeding; their participation in this proceeding exists for the purpose of advising and assisting the Regional Water Board.

HEARING PROCEDURE

The Board meeting, of which this hearing is a part, will start at 9:00 a.m. Interested persons are invited to attend. When the agenda item is called, staff will present the matter under consideration, after which oral statements from parties or interested persons will be heard. For accuracy of the record, all important testimony should be in writing. The Board will include in the administrative record written transcriptions of oral testimony that is actually presented at the hearing. Oral testimony may be limited to five minutes or less for each interested person, depending on the number of interested persons wishing to be heard.

Parties or interested persons with similar concerns or opinions are encouraged to choose one representative to speak and are encouraged to coordinate their presentations with each other.

Parties will be advised after the receipt of public comments, but prior to the date of the hearing, of the amount of time each is allocated for presentations. That decision will be based upon the complexity and number of issues under consideration, the extent to which the parties have coordinated, the number of parties and interested persons anticipated, and the time available for the hearing. The parties are invited to contact staff not later than **October 19, 2017**, (two weeks prior to the hearing) to discuss how much time they believe is necessary for their presentations, and staff will endeavor to accommodate reasonable requests. At the conclusion of testimony, the Board will deliberate in open or close session, and render a decision.

The Board does not generally require the prior identification of witnesses, the cross examination of witnesses, or other procedures not specified in this notice. Parties or persons with special procedural requests or requests for alternative hearing procedures should contact staff, who will endeavor to accommodate reasonable requests. Objections to any procedure to be used during this hearing must be submitted in writing no later than close of business 15 business days prior to the date of the hearing. (Any objections related to the amount of time allocated for parties' presentations must be submitted within two business days of notice thereof, if that date is less than 15 business days before the hearing.) Absent such objections, any procedure not specified in this hearing notice will be waived pursuant to section 648(d) of title 23 of the California Code of Regulations. Procedural objections will not be entertained at the hearing.

If there should not be a quorum on the scheduled date of this meeting, all cases will be automatically continued to the next scheduled meeting on **December 7, 2017**. A continuance will not extend any time set forth herein.
