REVISED TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRS) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT AND RESPONSE TO COMMENTS FOR THE JOINT OUTFALL SYSTEM, WHITTIER NARROWS WATER RECLAMATION PLANT, EL MONTE, CA (NPDES PERMIT NUMBER CA0053716, CI-2848)

The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) staff has revised the tentative WDRs and NPDES permit dated April 17, 2021, based on comments received by the May 17, 2021 public comments deadline. A copy of the revised tentative Order and written responses to all comments received are enclosed. Changes to the tentative WDRs and NPDES permit appear in strikethrough and underline format. Written comments are not being solicited regarding the revised tentative Order.

In accordance with administrative procedures, the Los Angeles Water Board at a public hearing to be held on **June 10, 2021, at 9:00 a.m., in a virtual meeting**, will consider the enclosed revised tentative requirements and comments submitted in writing regarding the tentative Order. The Los Angeles Water Board will hear any testimony pertinent to the revised tentative Order. It is expected that the Los Angeles Water Board will take action at the hearing; however, as testimony indicates, the Board, at its discretion, may order further action by staff.
