

 Discussions between the City of Los Angeles and Regional Board staff on water quality objectives for the plants

#### Staff Report.

Ms. Blythe Ponek-Bacharowski, Municipal Permitting Unit Chief

- Gave background information clarifying how the L.A. Glendale permit differs from the Tillman permit
- No Groundwater monitoring was required for either of the permits
- Both plants generate recycled water that services for many uses
- The chloride limit increased from 150 mgl to 190 mgl at Tillman
- The City believes the limits should be modified to 190 mgl and a revision was granted by Regional Board staff with the proposed modification
- Thirty percent of all recycled water occurs within this region
- Talked about the outstanding issues that have not been resolved
- The City argues that ground water recharge should not be applied
- The City recommends that a prohibition be added to both permits
- The City recommended increases of chloride concentrations

## Board questions, discussion, and concerns:

- Asked for clarification as to what type of irrigation the water is being used for
- Time frame for the 190 mgl limit?
- Asked for clarification on results of the studies for the permit
- What happens if the ground water increases?

After many questions and much discussion by the Board, there was a motion.

<u>MOTION:</u> To approve the waste discharge requirements and water recycling requirements with the following changes:

#### Add:

"or other requirements" into the Glendale reopener on page 13a-15R. Number the existing reopener paragraph 1.

#### Add paragraph 2.

The City of Los Angeles, Heal the Bay, and Regional Board staff will convene a workgroup to determine the best approach to addressing the competing issues associated with promoting water recycling and protecting groundwater in Los Angeles County. This order and the related Monitoring and Reporting Program shall be reopened by June 15, 2008. In the interim: (a) The groundwater monitoring requirements shall be stayed; (b) The permittee will not be required to design or construct additional wells to comply with the aforesaid monitoring requirements; and (c) The trigger mechanisms, set forth in section 1, paragraph 5, shall be stayed.

All other provisions and requirements of this order, the Monitoring and Reporting Program, and the Water Reclamation Requirements shall remain in effect.
