State Board Vice Chair and Liaison Fran Spivy-Weber talked about State Budget issues and the cut of one third of unfilled vacancies. She also indicated that all State Board retired annuitants were relieved from their duties due to these cutbacks.

Ms. Spivy-Weber stated that the State Board will meet and vote on the Once through Cooling Draft Policy at the December Board meeting.

She reminded the Board members of the October 26 -27, WQCC meeting and urged them to attend, stating that the topics discussed will include the State budget, sustainability, and other issues.

Executive Officer Tracy Egoscue announced the Consent items as follows: 7, 8, 9, 10, 11, and 12

Members asked that Item 12 be excluded from the vote for Consent because there were some questions that needed clarification prior to being voted on.

MOTION: To deem non-controversial and approve Agenda Item(s): 7, 8, 9, 10, and 11.

First: Vice Chair Madelyn Glickfeld Second: Board Member Steve Blois Vote: Approved by unanimous vote.

*This matter was delegated to the Executive Officer's authority, and the staff presentation waived. Public comment was allowed, and there were questions and concerns expressed by the Board, however, no voting took place for this matter.

Item 13. Clean Water Act Section 401 Water Quality Certification, County of Los Angeles, Maintenance Clearing of Engineered earth-bottom Control Channels.

Executive Officer Tracy Egoscue briefed the board on this matter indicating under the Clean Water Act, the Board must act within 12 months after the certification or the application is deemed complete, and therefore, in July of this year (2009), the Regional Board waived the right to act on this 401.

Ms. Egoscue stated that the County is able to clear channels during the wet season as they have done for the past six years. She also clarified there are additional requirements that have been proposed by Regional Board staff, and staff has certified the application from Los Angeles County flood Control District as complete, and she proposes bringing back a Waste Discharge Requirement to the Board for further clearing in subsequent years.

Board Member Comments, and questions:

- Pleased with the feasibility studies and the requirements that were added amending the original certification
- Expressed concern about Los Angeles River and Compton Creek, Reaches 24 and 25
- Asked Mr. Mark Pestrella for the County's assurances for protecting the L.A. River and Compton Creek, and to alleviate the concerns posed by stakeholders that the lands will be dredged and bulldozed
- Asked the County to include Friends of the L.A. River and other Stakeholders in the public process
- Asked the County for clarification as to what the County has done in other areas to make sure that there's some very smart stormwater work and the provision of green space for renewing urban areas?
- Believe that the Staff Report left out important information

Mr. Mark Pestrella, Los Angeles County Department of Public Works

- Compton Creek is not designed to handle a hundred year flood
- Compton Creek has 60 year flood protection
- The County wants to continue to be stewards of the L.A. River

• The County is looking forward to cooperating with the Board and moving forward both in the water quality arena, flood protection arena, water conservation arena, and also the environmental arena

Item 14. Development of Water-Effect ratios (WERs) to Modify Water Quality Objectives to Reflect Site-Specific Conditions in the Los Angeles Region.

Staff Report. Ms. Renee Purdy, Basin Plan Coordinator (Ms. Purdy made, but was not limited to the following points in her presentation.)

- Gave background history on WERs
- Talked about factors affecting metal toxicity
- The WERs that have been adopted to date, and future WERs for future consideration
- Discussed copper limits for POTWs at Tillman, Burbank and Glendale plants
- Noted the stakeholder concerns are the need to set minimum number of sample requirements in the region, preventing degradation of existing water quality, and addressing variability
