Update from State Board.

*Ms.* Fran Spivy-Weber gave a report for the Once Through Cooling Policy, which has still not gone through to Office of Administrative Law (OAL) office, but is anticipated that it will in August 2010. She also indicated that Mr. Tom Howard will be the new Director at State Board, and his position will be noticed for Monday July 12, 2010.

The Delta Report will be out Friday for approval to be considered in the State Board August meeting. Also, the Enforcement Policy has been approved.

Item 7. Consideration of a proposed Basin Plan Amendment to incorporate a Total Maximum Daily Load (TMDL) for indictor bacteria in the Los Angeles River Watershed.

Ms. Alexis Strauss, USEPA gave brief opening comments. (In her remarks she stated but was not limited to the following remarks):

- Asked the board to support adoption of the TMDL
- USEPA is under Consent Decree and the TMDL needs to go forward
- Discussed the adoption process
- EPA is establishing 10 other TMDL projects
- Talked about the advantages of this TMDL

Staff presentation. Ms. LB Nye, Unit Chief TMDL (*Ms. Nye made but was not limited to the following points in her presentation*):

- L.A. River TMDL is similar to most TMDLs that have been adopted
- This TMDL uses fresh water depth exceedance rates
- This TMDL has a phase Implementation Plan.
- Feature in the TMDL initiated by Cleaner Rivers through Effective Stakeholder TMDLs (CREST) Outreach
- Discussed the Stakeholder process
- Discussed the LA River Watershed Reaches (18 in all)
- The Reaches are impaired and exceed criteria for bacteria most of the time
- The TMDL should protect downstream Reaches
- Staff recommends the Board embrace the Implementation Schedule
- The Implementation Plan is flexible
- Discussed the Bacteria TMDL schedule
- The costs are based on discharger estimates
- Implementation actions taken will overlap with other implementation actions
- Discussed the MS4 Implementation, incorporated into the MS4 permit
- Received 36 comment letters
- Cost is a big concern for stakeholders
- TMDL determines the allocations, but does not dictate the language in the permit
- At least one commenter is concerned with Wet Weather achievability
- Heal the Bay and Santa Monica Baykeeper have concern that the Implementation Schedule is too long

Cleaner Rivers through Effective Stakeholders TMDLS (CREST) by Ms. Donna Chen, and Mr. Dustin Bambic, (in support) who made the following points:

- Discussed the Stakeholder meetings and workshops held
- They held 37 steering and /or Technical meetings
- Indicated that CREST mainly focused on dry weather
- Talked about the load Reduction Strategy
- L.A. River has 56 Outfalls, and its tributaries has 66 outfalls
- Discussed the Dry Weather costs

Consolidated presentation representing several (CPR) cities. (*in their presentations, the following points were made, but were not limited to the following*):

Mr. Richard Watson (opposed)

- Discussed plans for the river
- Indicated that costs are disproportionate
- Cities cannot reasonably afford the TMDLs
- This TMDL is contrary to the concrete portion of this river-bed

Dr. Susan Paulsen (opposed)

- Bacteria comes from many uncontrollable sources, i.e. Birds, human sewage, and POTW discharges
- Human sources pose the greater risks and are the ones we should focus on
- Non-human sources dominate in Reach 2
- Don not believe the TMDL accounts for natural sources of bacteria
- Recommend the recommendations for L.A. River Dry Weather be re-evaluated
- Concerns with Wet Weather are the volumes of flow
- Gave recommendations for the Wet Weather TMDL

Mr. Richard Montevideo (opposed)

- The L.A. River is unlike any other river
- EPA has discretion to not adopt a TMDL for bacteria
- This Board is charged with applying with CWC 13241, which requires standards to ensure "reasonable protection" of uses
- California law does not require restoration of LA River to receive its potential
- CEQA compels this Board to consider legitimate alternatives
- There is no evidence that Wet Weather TMDL can be complied with
