- 6.a. Update from State Board was presented by Mr. Steve Moore, SWRCB. (*Mr. Moore made, but was not limited to the following points*):
  - Currently developing flow water quality objectives
  - New Division of Drinking Water Programs; In 1993 did a Safe Drinking Water Plan for the State
  - State Board is currently accepting comments until December 15, 2014 for the Safe Drinking water plan update
  - Water Recycle enhancement around the State
  - There is currently landmark legislations, SB 445 for Underground Storage Tanks

6.b. Introduction to the new Division of Drinking Water Program at the State Board. (\*This matter is postponed to the February 12, 2015 Board meeting.)

7. Public Forum.

\*There were no speakers during the Public Forum.

Chair Stringer Administered the Oath.

- 12. Ms. Laura Valles, Valles & Associates, and Ms. Joni Byun, Nakatomi & Associates gave an update on the Carousel Tract Community meetings, and current results of the public participation and public view of those meetings, the process, lessons learned and next steps.
  - Discussed the Scope of Work
  - Public complained that Information in previous meetings was limited, and over-technical
  - The public had a lack of trust for the Regional Board
  - Designed 7 meetings
  - Had 5 general meetings, and 1 meeting was conducted in Spanish, and the other was an open meeting
- 8. Port of Los Angeles, Berths 212-224, redevelopment.

Staff report was made by Mr. Michael Lyons, Staff Scientist. (During Mr. Lyon's presentation, he made, but was not limited to the following points):

- Port proposed one-time dredging
- Tentative options reflect options proposed by the Port
- Ocean disposal is 21,800 cubic yards
- Dredged material deemed suitable for disposal at L.A.- 2
- Ocean disposal is not beneficial reuse
- The Order shall expire in 2017

*Mr.* Robert Christensen, Port of Los Angeles indicated that the Port is in support of the permit, commended Regional Board staff that worked with the Port on the permit. He indicated that in June 2014, the Port did a characterization on the material.

- A Member asked that if we monitor and find that there are pollutants that cause problems, how we remedy that problem.
- Are Effect Range Lows (ERLs) appropriate, and do we use them?

Staff report by Dr. Ginachi Amah, Regional Programs. (During Dr. Amah's presentation, the following points were made, but she was not limited to these points.)

- Channels with existing REC Use are L.A. River, Compton Creek, and Wilson Canyon Creek
- Gave summary of RECUR efforts
- Discussed designated existing uses
- Potential Recreational (Rec) Use Designations
- Discussed Intermittent Rec Use Designations
- Discussed the general comments received
- Staff recommendation is to adopt the tentative Resolution retaining the designated Recreational Uses

 Consideration of proposed Resolution (amendment) to authorize the Executive Officer to sign the revised Memorandum of Understanding (MOU) with the City of Malibu and the State Water Resources Control Board regarding the implementation of the Basin Plan amendment Prohibiting On-site Wastewater Disposal Systems in the Malibu Civic Center Area.

Staff report presented by Dr. Eric Wu, Unit Chief. (Dr. Wu made, but was not limited to the following remarks during his presentation.):

- Discussed the background for the prohibition
- Discussed key prohibition milestones
- MOU to implement the prohibition
- Malibu to build a centralized wastewater treatment system
- Phase I to be completed by June 1, 2017
- Discussed the challenges that have caused delays
- Discussed milestones for Phase I, 2011 MOU
- Additional studies completed
- Challenges requiring additional time Sought additional time for funds from State Board Revolving fund

- Phase II milestones and timelines
- Comments were received from Ms. Joan Lavine, and Heal the Bay
- Change sheet reflects change of date for the completion of Phase I from November 5, 2017 to June 30, 2017

- Asked Mr. Thorsen for updates on the progress, and indicated that his previous progress reports have been appreciated as well
- Asked Executive Officer Sam Unger to work with the city of Malibu on Phase I and 2

11. Workshop on the development of Salt and Nutrient Management Plans (SNMPs) in the Los Angeles Region.

Staff report was given by Dr. Ginachi Amah.

Dr. Amah gave background history and discussed the Recycled Water Policy. The Regional board's role is to facilitate interaction and share information. There were annual Workshops. The Regional board provided regulatory assistance on SNMP requirements, and provided technical and regulatory oversight.
