The Los Angeles River Upper Reach 2 Watershed Management Area (LAR UR2 WMA) Cities of Bell (4B190153001), Bell Gardens (4B190139002), Commerce (4B190161001), Cudahy (4B190164001), Huntington Park (4B190177001), Maywood (4B190192001), Vernon (4B190216001), and Los Angeles County Flood Control District (4B190107101) continued implementation of the Coordinated Integrated Monitoring Program (CIMP) activities approved of in your letter of February 12, 2016.

Dry-weather water quality monitoring occurred on July 19, 2017, while wet-weather water quality monitoring occurred after January 1, 2018.
