**SUBMITTAL OF SEMI-ANNUAL DATA (JULY 1 – DECEMBER 31, 2017)
UPPER SAN GABRIEL RIVER
COORDINATED INTEGRATED MONITORING PROGRAM**

On behalf of the Upper San Gabriel River Watershed Management Group, the County of Los Angeles, Los Angeles County Flood Control District (District), and the Cities of Baldwin Park, Covina, Glendora, Industry, La Puente, South El Monte, and West Covina (collectively the Group) are submitting the Semi-Annual Data package for the Upper San Gabriel River Coordinated Integrated Monitoring Program. The data package is being submitted in the California Environmental Data Exchange Network (CEDEN) format.

Between the reporting period of July 1 through December 31, 2017, the following monitoring events were conducted:

1. On July 20, 2017, the Group conducted dry weather sampling at USGR_SJC_C-1 in San Jose Creek Reach 1, USGR_WCW_BP in Walnut Creek Wash, and non-stormwater outfall site USGR_SJCRK-79a. No flow was observed at USGR_R4_RAM in San Gabriel River Reach 4; therefore, no sample was collected.
2. On July 20, 2017, the District attempted to conduct dry weather sampling at Mass Emission Station S14, but no flow was observed; therefore, no sample was collected.
3. During this reporting period, there were no wet weather sampling events.

The receiving water monitoring portion of the Coordinated Integrated Monitoring Program also includes participation by the Cities of El Monte, Irwindale, La Habra Heights, and Walnut through a Memorandum of Understanding with the County of Los Angeles.
