SUBMITTAL OF SEMI-ANNUAL DATA (JULY 1 – DECEMBER 31, 2017) MARINA DEL REY COORDINATED INTEGRATED MONITORING PROGRAM

The County of Los Angeles, Los Angeles County Flood Control District (District), and the Cities of Culver City and Los Angeles (collectively the Group) are submitting the Semi-Annual Data package for the Marina del Rey Coordinated Integrated Monitoring Program. The data package is being submitted in the California Environmental Data Exchange Network (CEDEN) format.

Between the reporting period of July 1 through December 31, 2017, the following monitoring events were conducted:

1. Dry Weather

- a. July 18, 2017 – critical dry weather sampling at receiving water monitoring site MdrH-MC in the Marina del Rey Harbor (MdrH) main channel
- b. Monthly dry weather sampling for MdrH Toxics TMDL in the harbor basins and main channel for Total PCBs and Copper:
 - i. July 18, September 27, and November 16, 2017, at MdrH-A, MdrH-C, MdrH-E, MdrH-G, and MdrH-MC
 - ii. August 23, October 17, and December 5, 2017, at MdrH-B, MdrH-D, MdrH-F, MdrH-H, and MdrH-MC



- c. September 20, 2017 – Toxics TMDL sediment chemistry and toxicity sampling in the harbor
 - d. October 12, 2017 – Toxics TMDL harbor fish tissue sampling in the harbor
 - e. December 15, 2017 – Toxics TMDL harbor mussel tissue sampling in the harbor
2. Wet Weather
- There was not any wet weather sampling event during this reporting period.
3. Weekly or daily sampling for the Marina del Rey Harbor Mother's Beach and Back Basins Bacteria TMDL at nine sites (MdrH-1 through MdrH-9)
