- SUBJECT: NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT ON PROPOSED MODIFICATIONS TO THE BEACH CITIES ENHANCED WATERSHED MANAGEMENT PROGRAM PURSUANT TO THE LOS ANGELES COUNTY MUNICIPAL SEPARATE STORM SEWER SYSTEM (MS4) PERMIT (NPDES PERMIT NO. CAS004001; ORDER NO. R4-2012-0175 AS AMENDED BY STATE WATER BOARD ORDER WQ 2015-0075 AND LOS ANGELES WATER BOARD ORDER NO. R4-2012-0175-A01)

On April 18, 2016, the California Regional Water Quality Control Board, Los Angeles Region (Los Angeles Water Board or Board) approved the Beach Cities Watershed Management Group (Beach Cities) Enhanced Watershed Management Program (EWMP).

On December 15, 2018, Beach Cities requested as part of its 2017-2018 Annual Report and Adaptive Management Process, a modification to the Beach Cities EWMP as follows:

- Modify PIPP to better address watershed priorities through direct targeted outreach to residents
- The City of Torrance proposes to add infiltration drywells (or similar) as possible control structures that could be installed as distributed BMPs throughout the City to address the metals WQBELs in the Dominguez Channel Toxics TMDL
- Proposed source tracking study within the drainage areas to Santa Monica Bay Bacteria TMDL shoreline monitoring sites SMB 6-2 and SMB 6-5 to investigate significant wetweather sources of indicator bacteria and to inform a decision on appropriate source control measures or structural BMPs, if additional are needed
- Revise Category 2 Water Body Pollutant Combinations (WBPCs) to reflect the most recent approved State's 2016 303(d) list by adding mercury and arsenic in the Santa Monica Bay Watershed and removing ammonia in the Dominguez Channel Watershed.
