Opening presentations and cross-examination of witnesses continued from the Regional Water Board meeting held the previous day. The following parties gave opening statements including testimony from witnesses:

After the board members and Advisory Team asked questions of the designated parties, the Vice-Chairman closed the hearing to the public for closed session deliberations.

Chairman William Massey reconvened the meeting at 5:45 p.m. Vice-Chairman John Corbett made the following motion:

**Motion:** John Corbett proposed a motion for the Board to consider. He moved to direct the parties to follow the following process:

Designated parties shall provide to the Email Service List no later than 5 p.m. on Thursday April 27<sup>th</sup> their written suggested revisions to the Resolutions and WWDRs proposed by the Issuance Team. These suggestions will be considered by the Advisory Team in revising the Resolutions and WWDRs proposed by the Issuance Team. The Advisory Team will then circulate the revised WWDRs and Resolutions to the Email Service List by 5 pm on Monday, May 1<sub>st</sub>. They will then be before the Board for consideration at its meeting scheduled for May 8<sup>th</sup>. Oral comments by interested persons and the parties will be accepted as provided in the hearing procedure, which will be supplemented in the new future to specify additional procedures.

Mr. Corbett also moved to direct the parties to focus their comments on the following areas:

- 1. compliance of the WWDRs with Water Code section 13360.
- 2. identification of areas of expert disagreement and their effect on the validity of the WWDRs.
- 3. the aspects of PALCO's proposed WWDRs that may be comfortably integrated into the Issuance Team's versions; including PALCO's infrastructure provisions with enforceable dates.
- 4. the WWDRs' consideration of economics as required by applicable law.

Mr. Corbett further moved that the parties be admonished not to submit new evidence or argument as a part of their materials.

Mr. Corbett finally moved that the Board direct the Executive Officer to:

- 1. Develop a schedule for an expedited process for permitting all nonindustrial timberland owners; probably watershed-specific general waste discharge requirements; and
- 2. Schedule a study session on the TMDLs for Freshwater Creek and Elk River with a section on legal mechanisms for permitting compliance and enforcement.

Gerald Cochran seconded the motion. The motion passed unanimously.

There being no further business to come before the Regional Water Board, the meeting adjourned at 6:55 p.m. The next Regional Water Board Meeting is scheduled for May 8, 2006, in Santa Rosa.
