Mendocino Forest Products, LLC, has filed an application for renewal of waste discharge requirements. Staff of the North Coast Regional Water Quality Control Board (Regional Water Board) has prepared a tentative permit for this discharger containing limitations and provisions in accordance with the Federal Clean Water Act and the California Porter-Cologne Water Quality Control Act.

Mendocino Forest Products, LLC, owns a 300-million board foot sawmill complex in conjunction with a wood burning boiler for generation of steam for kiln heating, directly adjacent to Hensley Creek. The Facility consists of a paved log yard, sawmill, sorter/stacker, planer mill, lumber storage, wood treating facility, flooring facility, drying kilns, boilers, bone yard, vehicle maintenance shop, and offices which support lumber manufacturing, treatment and storage operations. The Discharger uses approximately 1.5 million gallons per day (MGD) during the dry season, and 50,000 gallons per day during the rainy season of pumped groundwater and municipal water for log sprinkling. The excess log yard runoff enters a return ditch and is directed to a recycle pond. When available, pond water is recirculated through the sprinkler system. During substantial storm events, the pond may overflow and discharge process water to Hensley Creek. Of the process wastewaters produced at the Facility, log deck sprinkler water is the only process wastewater discharged to a water of the United States; domestic wastewater, boiler blowdown and boiler cleaning wastewater are discharged to septic tank/leachfield systems onsite.

On the basis of preliminary staff review and application of lawful standards and regulations, the California North Coast Regional Water Quality Control Board (Regional Water Board) proposes to adopt Waste Discharge Requirements Order R1-2010-0084 for the Mendocino Forest Products Ukiah Sawmill Complex. Order R1-2010-0084 will impose more stringent effluent limitations for discharges from the log deck recirculation pond. This item will be open for public comment from September 23 to October 25, 2010.

Public Hearing Procedures

The Regional Water Board intends to consider adopting the tentative permit during a meeting to commence at the time and location as follows:

A public hearing to consider comments and objections to the proposed permit is scheduled for December 9, 2010, at 8:30 a.m., in Santa Rosa, California, or as announced in the Regional Water Board's agenda. The meeting will be held at the Regional Water Board's Office, located at 5550 Skylane Boulevard, Suite A, Santa Rosa, California. At the public hearing, the Regional Water Board will consider whether to affirm, reject, or modify the proposed waste discharge requirements.

In order for the Regional Water Board to consider any evidentiary material concerning this hearing, any documents, including written technical reports and other evidentiary material, must be received by the Regional Water Board no later than 5:00 p.m., on October 25, 2010, at 5550 Skylane Boulevard, Suite A, Santa Rosa, California 95403. All documents that are received timely will be distributed to the Regional Water Board members and interested persons. These records will also become a permanent part of the administrative record for this public hearing.

Except at the discretion of the Regional Water Board Chair, written material received after the above date will not be accepted. If the Chair chooses to accept late written material, that material will not be incorporated into the administrative record if doing so would prejudice the Discharger or the Regional Water Board staff. The Chair may choose to modify this rule upon a showing of severe hardship (California Code of Regulations, Title 23, sections 648.1 and 648.4).

All those who plan to testify at this hearing must submit written statements to the Regional Water Quality Control Board no later than April 30, 2010. The statements should provide the name of the witness, his or her qualifications (if an expert), and the scope of his or her intended testimony. The time limit for oral testimony or comments will be set by the Regional Water Board Chair and are subject to change. These time limits normally allow no more than 10 minutes each for Regional Water Board staff and Dischargers. All speakers are expected to honor these time limits. Other interested persons may also provide testimony at this public hearing. However, any testimony given by someone other than staff or the Discharger may be limited to 3 minutes and may only be given under the limited scope of summarizing or explaining any timely-submitted or late-accepted written evidence. No new evidence will be allowed to be presented at this public hearing. In an effort to be fair to all people who wish to testify at this public hearing, the Regional Water Board Chair may choose to use a timer to ensure that individuals stay within the time limits set by the Chair. The Chair also

requests that in order to avoid unnecessary repetitive testimony, that one spokesperson be selected to speak on behalf of many individuals, when those individuals share a common affiliation or interest.

The procedures governing Regional water Board meetings may be found at sections 647 et seq. and 648 et seq. of Title 23 of the California Code of Regulations, and are available upon request.

All issues raised in petitions brought to the State Water Resources Control Board pursuant to California Water Code section 13320 must be raised in the proceedings before the Regional Water Board. Pursuant to section 2050(c) of Title 23 of the California Code of Regulations, if the action or inaction that is the subject of the petition was taken by the regional board after notice and opportunity to comment, the petition will be limited to those substantive issues or objections that were raised before the Regional Water Board at the public hearing or in timely submitted written correspondence delivered to the Regional Water Board.

Document Review

The tentative Order, related documents, and comments received by the Regional Water Board will be on file and may be inspected or copied at the Regional Water Board's office, 5550 Skylane Boulevard, Suite A, Santa Rosa, California.
