On 11 July 2003, the Central Valley Regional Water Quality Control Board (Regional Board) adopted two Conditional Waivers of Waste Discharge Requirements for Discharges from Irrigated Lands in the Central Valley Region and Monitoring and Reporting Programs. The State Water Resources Control Board upheld these actions with revisions.

As directed by the State Board, Regional Board staff will present an information item at a joint meeting between the Regional Board and State Board concerning this matter.
