



# **Groundwater Quality Funding**

Recent legislative changes created two new groundwater quality funding (GWQF) programs to be implemented by the State Water Resources Control Board (State Water Board). These are:

- Proposition 1 Groundwater Sustainability Program (Assembly Bill 1471, Chapter 10)
- Site Cleanup Subaccount Program (Senate Bill 445, Hill, 2014).

#### HOW DO I APPLY?

Applicants seeking funding from either GWQF program will be able to apply using a single pre-application for both funding programs. State Water Board staff will evaluate pre-applications and determine which program, if any, is the most appropriate for each project; and, therefore, applicants do not need to designate a funding program preference. Applicants whose pre-application is successful will be invited to submit a final application for Proposition 1 Groundwater Sustainability or may be asked to submit supplemental documents for the Site Cleanup Subaccount Program as it does not have a Final Application. Applicants also may be advised to apply for another potential source of funds.

#### HOW ARE PROJECTS RANKED?

Currently there are no ranking criteria other than existing requirements in law. The State Water Board will adopt guidelines with project selection criteria for the Proposition 1 Groundwater Sustainability Program. The State Water Board may choose to select certain projects for funding over other projects if there are insufficient funds to fund all projects during the fiscal year or over the life of the programs.
