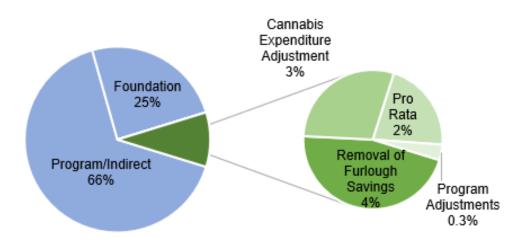

FY 2021-22 Waste Discharge Permit Fund Potential Fee Changes

NOTE: The proposed changes described below are only concepts at this time and are based on the data currently available. With the exception of the Winery General Order fees, all final changes will be included in the agenda item for the September 21, 2021 board meeting at which staff will propose the FY 2021-22 fee schedule for the Board's consideration. Storm Water

- **Construction** In an effort to spread the fees more equitably among dischargers, staff is proposing to increase the total number of disturbed acres upon which the maximum fee is based from 150 acres to 200 acres.
- Notice of Non-Applicability (NONA) No Discharge Staff is proposing a
 one-time application fee of \$200 for entities submitting a NONA and claiming the
 "No Discharge" option. The application fee is to cover staff time associated with
 reviewing the NONA and the required No Discharge Technical Report.
- **No Exposure Certification (NEC)** Staff is proposing to increase the application fee for NEC dischargers from \$150 to \$200 and reduce the annual fee from \$150 to \$75 to reflect the difference in staff workload associated with reviewing applications and ongoing annual workload.

Cannabis Cultivation

- **Per Acre Surcharge** Staff is proposing to assess a surcharge to Tier 2 enrollees of \$100 per disturbed acre greater than one acre to reflect the corresponding increased workload.
- **Indoor Cultivation Sites** Staff is proposing to split the current singular category into two fee categories to reflect the difference in workload associated with the various types of indoor cultivation sites.

• Conditionally Exempt Outdoor Cultivation Sites – Staff is proposing a new annual fee of \$185 for dischargers with conditionally exempt outdoor cultivation sites. The annual fee is to cover associated staff workload.

General Waste Discharge Requirements for Winery Process Water (Winery General Order)

At the July 6, 2021 board meeting, Fee Unit staff will be proposing a new fee schedule for dischargers enrolled in the Winery General Order that was adopted on January 20, 2021. The proposed fee schedule is based on the enrollment tiers specified in the Winery General Order and volume of process water discharged by the facility.

Facility Process Water Flow (gal/yr)	Enrollment Tier	Fee Amount
>10,000 to 30,000	Tier 1	\$750
>30,000 to 100,000	Tier 2	\$1,000
>100,000 to 300,000	Tier 2	\$1,200
>300,000 to 600,000	Tier 3	\$2,000
>600,000 to 1 million	Tier 3	\$3,000
>1 million to 3 million	Tier 4	\$7,000
>3 million to 7 million	Tier 4	\$13,000
>7 million to 15 million	Tier 4	\$19,000

Staff is also proposing fee reductions for dischargers enrolled in the following programs:

- Local Agency Oversight 50 percent fee reduction
- Approved Sustainability Program 10 percent fee reduction
