## CALIFORNIA ARMY NATIONAL GUARD, CAMP ROBERTS MILITARY RESERVATION – PROPOSED REVISION OF WASTEWATER TREATMENT PLANT WASTE DISCHARGE REQUIREMENTS

This letter notifies you of the availability of draft Order No. R3-2014-0046, which revises existing waste discharge requirements (WDRs) for sanitary wastewater discharges from Camp Roberts' Main Garrison and East Garrison wastewater treatment and disposal facilities. Staff intends to present draft Order No. R3-2014-0046 to the Central Coast Water Board for adoption at its meeting scheduled for November 13-14, 2014. Persons wishing to comment on or object to draft Order No. R3-2014-0046 must submit comments in writing to the address above no later than October 8, 2014. The Central Coast Water Board will not accept late comments or other written submissions on draft Order No. R3-2014-0046 unless the Chair rules that exclusion would create a severe hardship and that the late submission will not prejudice any party or the Central Coast Water Board. Any person asking to submit late materials must explain why the materials were not submitted earlier. The Chair will rule on any late submissions at or before the hearing. Late submissions that consist of evidence (as opposed to policy statements or comments) are generally prejudicial unless all designated parties and Central Coast Water Board's staff have time to consider the evidence before the meeting. If the Central Coast Water Board's staff proposes changes to draft Order No. R3-2014-0046 before the Central Coast Water Board meeting, parties and interested persons will have an opportunity to comment on the proposed changes at the November 13-14, 2014 meeting.
