SUBJECT: **BOARD WORKSHOP ON TEMPORARY CONDITIONAL BYPASS AND DISCHARGE FROM THE CITY OF LOS ANGELES, HYPERION TREATMENT PLANT (HTP) AND WEST BASIN MUNICIPAL WATER DISTRICT, EDWARD C. LITTLE WATER RECYCLING PLANT**

The Los Angeles Regional Water Quality Control Board (Los Angeles Regional Water Board) will hold an informational workshop to discuss the temporary conditional bypass and discharge from the City of Los Angeles, Hyperion Treatment Plant and West Basin Municipal Water District (West Basin), Edward C. Little Recycling Plant.

The City of Los Angeles, Bureau of Sanitation requested approval to temporarily divert secondary effluent discharged from the normally used 5-mile outfall to the 1-mile outfall during the necessary replacement of the effluent pumping plant header, scheduled for September 2015 (2015 Effluent Pumping Plant Header Replacement Project or 2015 EPP Project). The diversion is required to conduct major overhaul and replacement work on the effluent pumping system and is scheduled from September 21, 2015 to November 2, 2015, a total of 6 weeks (five weeks of planned overhaul plus one week of contingency time).

The West Basin Edward C. Little Recycling Plant discharges brine through the HTP 5-mile outfall. West Basin requested to temporarily divert brine discharged from the normally used 5-mile outfall to the 1-mile outfall during the necessary replacement of the effluent pumping plant header.

At the workshop, City of Los Angeles staff will make a brief presentation on the scope of the upcoming EPP Project, the need for the project, the monitoring plan before, during, and after the project, and the status of the public outreach conducted by the City of Los Angeles.
