

SUBJECT: TRANSMITTAL OF CEQA NOTICE OF DECISION AND CERTIFICATE OF FEE EXEMPTION FOR BASIN PLAN AMENDMENTS INCORPORATING TOTAL MAXIMUM DAILY LOADS FOR NITROGEN COMPOUNDS AND RELATED EFFECTS IN CALLEGUAS CREEK, ITS TRIBUTARIES AND MUGU LAGOON

Amendments to the Water Quality Control Plan for the Los Angeles Region (Basin Plan) have recently received final approval from the U.S. Environmental Protection Agency, Region IX. The amendments incorporate total maximum daily loads (TMDLs) for nitrogen compounds and related effects in Calleguas Creek, its tributaries and Mugu Lagoon.

The Regional Board's planning process has been certified as "functionally equivalent" to preparation of an Environmental Impact Report under section 21080.5 of the California Environmental Quality Act (CEQA). Completion of the CEQA review process for the environmental documents prepared for Basin Plan amendments involves filing of a "Notice of Decision" rather than a "Notice of Determination" and a final Certificate of Fee Exemption.

Enclosed are the Notices of Decision and the final Certificate of Fee Exemption with attachments for the Basin Plan amendments adopted by the Los Angeles Regional Board on October 24, 2002 under Resolution 02-017.

This Notice of Decision is to advise you that the Los Angeles Regional Water Quality Control Board (Regional Board) has determined that the above-referenced project has been approved. On October 24, 2002, the Regional Board adopted an amendment to the *Water Quality Control Plan for the Los Angeles Region (Basin Plan)*; namely Resolution No. 02-017 (Amendment to the Water Quality Control Plan for the Los Angeles Region to incorporate a Total Maximum Daily Load (TMDL) for Nitrogen Compounds and Related Effects in the Calleguas Creek, Its Tributaries, and Mugu Lagoon). This Basin Plan amendment was subsequently approved by the State Water Resources Control Board (Resolution No. 2003-0023) on March 19, 2003; by the Office of Administrative Law on June 5, 2003; and by U.S. Environmental Protection Agency Region IX on June 20, 2003.

The Regional Board has made the following determinations regarding the above-described project:

- 1. The project will not have a significant effect on the environment (see attached CEQA Checklist).
- 2. A functional equivalent document was prepared for this project pursuant to the provisions of CEQA (see attached Staff Report)
- 3. Mitigation measures were not made a condition of the approval of the project.
- 4. A statement of overriding considerations was not adopted for this project.
- 5. Findings were made pursuant to the provisions of CEQA.
