ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; EVERGREEN COMMUNITIES, FLORIN VINEYARDS PROJECT (WDID#5A34CR00849A3), SACRAMENTO COUNTY

This Order responds to the 25 March 2024 and 24 April 2024 requests for an amendment of the Florin Vineyards Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00849). The original Water Quality Certification (Certification) was issued on 28 June 2022. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Evergreen Communities is requesting a change in ownership from Evergreen Communities to Taylor Morrison. Additionally, Evergreen Communities is also requesting a modification to reflect a reduction in temporary impacts listed in Table 1 (page 4) and Table 4 (page 20).

The Certification is amended to reflect Jay Pawlek as the representative of Taylor Morrison. Temporary Impacts are amended as shown below:
