The County of Kern operates the Bakersfield Metropolitan Sanitary Landfill. The facility is currently governed by Waste Discharge Requirements, Order No. R5-2005-0098. The landfill is approximately 17 miles east of Bakersfield. The 2,285-acre facility contains one inactive 54-acre lined waste management unit known as Unit Phase 1 and one 175-acre waste management unit known as Unit Phase 2A. This Order revises the existing Waste Discharge Requirements to allow the acceptance of treated wood waste to Unit Phase 2A.

A **formal** public hearing concerning this matter will be held during the Regional Water Board meeting which is scheduled for:

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Regional Water Board no later than **23 April 2007**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item must submit testimony, evidence, and/or comments in writing to the Regional Water Board no later than **23 April 2007**. Written testimony, evidence, or comments submitted after **23 April 2007**

All interested persons may speak at the Regional Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony will be limited in time by the Regional Water Board Chair.
