NOTICE OF PUBLIC HEARING

SYNAGRO WEST, LLC AND GARY SILVA
SILVA RANCH WET WEATHER BIOSOLIDS STORAGE FACILITY
CLASS II WASTE PILE AND CLASS II SURFACE IMPOUNDMENT
CONSTRUCTION, OPERATION, AND CLOSURE
SACRAMENTO COUNTY

Synagro West, LLC owns and operates the Silva Ranch Wet Weather Biosolids Storage Facility at the Silva Ranch on land owned by Gary Silva. New waste discharge requirements (WDRs) for the facility are proposed to provide requirements for construction, operation, monitoring, and closure of a lined waste management unit to be used for temporary storage of biosolids during wet weather when they cannot be applied to land. Details regarding the proposed facility are included in the Findings and the Information Sheet of the tentative WDRs that are available on the Regional Water Board's website at www.waterboards.ca.gov/centralvalley/tentative.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **30 July 2007**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Regional Board no later than **30 July 2007**. Written evidence or comments submitted after **30 July 2007** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
