WASTE DISCHARGE REQUIREMENTS
for
CALIFORNIA DAIRIES, INC.
TIPTON MILK PROCESSING FACILITY
TULARE COUNTY**

California Dairies, Inc. (CDI) owns and operates a milk processing facility in Tipton, California. Treated wastewater from the facility is discharged to ponds and Morrison Ditch, a water of the United States. The California Regional Water Quality Control Board (Regional Water Board) will consider tentative Waste Discharge Requirements (WDRs) for renewal of NPDES Permit No. CA0082805 to authorize continued discharge and a Cease and Desist Order to provide CDI a time schedule to address capacity and operational issues. The tentative WDRs will authorize an increase in the discharge to ponds from 0.45 mgd to 3.1 mgd and will include new effluent limits for zinc and ammonia. This item will be considered by the Regional Water Board at a public hearing during its meeting scheduled for:

The designated parties for this hearing are as follows:

- Staff of Central Valley Regional Water Board
- California Dairies, Inc.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **noon on 23 June 2008**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item must submit such comments in writing to the Regional Board no later than **noon on 23 June 2008**. Written testimony or comments submitted after **noon on 23 June 2008** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.

Beginning on 23 May 2008, interested parties may download the proposed WDRs from the Regional Water Board's internet website at www.waterboards.ca.gov/centralvalley/board_decisions/tenative_orders/. The Central Valley Water Board's website had changed to a new format. Even though the content has not changed, some links may have changed due to this process. If you do not have Internet access, these documents may be inspected and copied at the Regional Water Board's office at 1685 E Street, Fresno, California, weekdays between 8:00 a.m. and 5:00 p.m. by appointment.
