TO ALL CONCERNED PERSONS AND AGENCIES:

Enclosed are the tentative Waste Discharge Requirements (NPDES No. CA0083241) and Cease and Desist Order for Nevada County Sanitation District No. 1, Cascade Shores Wastewater Treatment Plant. Any comments or recommendations you may have concerning the tentative orders must be submitted to this office no later than 5:00 p.m. on **8 July 2008**, in order for full consideration to be given to them prior to the July31/August1 Regional Water Board meeting. Written materials submitted after 5:00 p.m. on 8 July 2008 will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

A Notice of Public Hearing (Notice) concerning the tentative Orders is also enclosed. Regulations require that the Discharger publish the Notice in a local newspaper commencing no later than **9 June 2008**. The expense of publication is to be paid by the Discharger. Additionally, by 9 June 2008 post one (1) copy at the Notice at:

- The nearest city hall or county courthouse
- The post office nearest to the Facility (if allowed), and
- The public entrance of the Cascade Shores facility

Proof of posting, using the enclosed form, shall be filed with this office by **23 June 2008**. Proof of publication shall consist of an affidavit from the newspaper along with a copy of the published notice.
