TENTATIVE REVISED WASTE DISCHARGE REQUIREMENTS
FOR
POST-CLOSURE MAINTENANCE OF
HUMBOLDT ROAD PRIVATE PROPERTIES OPERATIONAL UNIT
BUTTE COUNTY

On 16 December 2008, Thomas V. Fogarty and Mary R. Fogarty, Trustees of the Thomas V. and Mary R. Fogarty Revocable Trust granted Chico Redevelopment Agency (Discharger) deed to the portion of real property containing the Humboldt Road Private Properties Operational Unit (Unit), a closed landfill about two miles east of the intersection of State Routes 32 and 99 in Chico. The Waste Discharge Requirements are being revised to reflect the ownership change, new financial assurance mechanism, and revise the post-closure monitoring and reporting program.

A public hearing concerning this matter will be held during the Regional Water Board meeting which is scheduled for:

The designated parties for this hearing are as follows:

- Chico Redevelopment Agency

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **20 April 2009**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Regional Board no later than 5 p.m. on **20 April 2009**. Written materials submitted after 5 p.m. on **20 April 2009** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair
