TENTATIVE CEASE AND DESIST ORDER AMENDMENT

For

**CITY OF LIVE OAK
WASTEWATER TREATMENT PLANT
SUTTER COUNTY**

The City of Live Oak (Discharger) owns and operates a collection system and wastewater treatment plant that provides sewage service to the community of Live Oak consisting of approximately 8,000 people. Disinfected secondary effluent is currently discharged to Reclamation District 777 Lateral Drain No. 1, which is tributary to Main Canal and the Sutter Bypass. On 5 February 2009, the Regional Water Quality Control Board (Regional Water Board) adopted a Cease and Desist Order (CDO) that provides a time schedule for the Discharger to consider wastewater regionalization to the City of Yuba City wastewater treatment facility. The new adopted CDO grants a time schedule and provides for exemption from mandatory minimum penalties for copper, cyanide, biochemical oxygen demand (BOD), total suspended solids, coliform and diazinon; however, the CDO does not provide interim limitations for these constituents as required by the California Water Code for monetary penalty exemption. The proposed amendment adds performance-based interim limitations to the adopted CDO, as necessary for the Regional Water Board to exempt the Discharger from monetary penalties.

Only designated parties will have the following rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Regional Water Board no later than **23 March 2009**. The request must explain the basis for

status as a designated party and, in particular, how the person is directly affected by the discharge.


The tentative CDO Amendment was issued on 5 February 2009. Persons wishing to comment on the limited scope of the proposed amendment, as shown in underline/strike-out text on the tentative document, shall submit testimony, evidence, if any, and/or comments in writing to the Regional Water Board no later than 5:00 p.m. on **9 March 2009**. Written evidence or comments submitted after 5:00 p.m. on **9 March 2009**, or outside the scope of the proposed amendment, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party. All designated parties and interested persons may speak at the Regional Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
